



## MedStar Family Choice Maryland HealthChoice 2022 Added Benefits for Pregnant Members

Dear MedStar Family Choice Participating Provider:

Please be advised that Maryland Medicaid pregnant members may access additional supports related to doula and home visiting services. Newly implemented benefits began in 2022 for pregnant Medicaid members to help improve outcomes for this population.

Both doula and home visiting providers must be fully enrolled in Maryland Medicaid ePREP, and must contract with managed care organizations to provide these newly covered services for MedStar Family Choice members.

The following transmittals contain informational updates for both new benefits PT 37-22 (<u>Doulas Transmittal No. 1</u>) and PT 35-22 (<u>Home Visiting Transmittal No. 1</u>).

The Maryland Department of Health also provided additional guidance for network adequacy requirements specifically for doulas. For any geographical area that network adequacy requirements are not yet met, the managed care organization must enter into single case agreements with the doulas to render the covered benefit to members. Doulas must have an individual NPI, not be listed on any exclusion list, and comply with the established then current HealthChoice Doula Program Manual. RE: Doula Network Adequacy Standards for the Maryland HealthChoice Program

NOTE: Please ensure that appropriate staff members in your organization are

informed of the contents of this memorandum.

The Maryland Department of Health (MDH) has developed guidance for managed care organization (MCO) network standards for the doula provider type in the Maryland HealthChoice Program under the authority of 42 CFR § 438.206, which permits States to use quantitative or qualitative standards to determine network adequacy.

The quantitative network adequacy standards for doulas are outlined on the following page.

## **Doula Network Adequacy Standards**

Geographical Region	Counties	Number of Doulas Required
Urban	Baltimore City	4 at minimum
Suburban	Anne Arundel, Baltimore, Carroll, Harford, Howard, Montgomery, and Prince George's	4 at minimum in each county
Rural: Eastern Shore	Caroline, Cecil, Dorchester, Kent, Queen Anne's, Somerset, Talbot, Wicomico, and Worcester	2 at minimum in the region
Rural: Southern Maryland	Calvert, Charles, and St. Mary's	2 at minimum in the region
Rural: Western Maryland	Allegany, Garrett, Frederick, and Washington	2 at minimum in the region

Until the above standards are met, effective immediately, MCOs must enter into single case agreements (SCAs) with out-of-network doulas to render the covered benefit as required under 42 CFR § 438.206(b)(4). For purposes of this transmittal, out-of-network (OON) doulas are doulas who are not currently enrolled with Medicaid and would otherwise not be able to contract with an MCO to become an in-network provider. MDH will reevaluate the adequacy of doula enrollment and each MCO's doula network on an ongoing basis until the network adequacy standards are met.

MDH recommends MCOs primarily contract with doulas who are on a pathway towards full Medicaid enrollment and possess all required certifications in COMAR 10.09.39.02. However, MDH recognizes that SCAs may be necessary with doulas who may not have all of the certifications required. To that end, doulas with the following certifications may be contracted for OON arrangements:

- Birth in Color: Community Based Doula Certificate;
- Birthers United: Community Birth Doula Certificate; and
- Doula Trainings International: Full-Spectrum Doula Certification.

Doulas who have been approved by another State's Medicaid program, and by at least one of the approved certifications accepted by Maryland Medicaid, may also be contracted for SCAs.

MCOs who enter into SCAs must do the following:

• Confirm the doula has an individual NPI.

- Perform federal exclusion checks and verify an individual doula's training/certifications.
- Ensure out-of-network doulas operating with a SCA bill claims in accordance with the HealthChoice Doula Program Manual <u>found on our website</u>.

Because this solution is being implemented in response to limited enrollment of doulas in Maryland Medicaid, MCOs are permitted to use the free agent flag on encounters for services delivered by out-of-network doulas contracted through SCAs.

As a reminder, the free agent process exists for special circumstances where a provider is not enrolled with Maryland Medicaid and not part of any MCO's network (e.g., out-of-state emergency providers). To ensure encounters for doula services are successfully submitted to MMIS, MCOs must add the out-of-network doula's NPI to the MCO network file and submit out-of-network doula encounters using the free agent flag for MMIS acceptance. This free agent process is intended to be available only on a short term basis. Doulas are still expected to enroll in Medicaid per normal requirements. Once network adequacy is found to be sufficient, only doulas enrolled in Medicaid will be able to continue to bill MCOs for services. An additional transmittal will be issued when network adequacy is found to be sufficient, indicating that the free agent process will be discontinued within ninety (90) days.
